# Core Services

Hi-Borde's operations are divided into three synergistic business units, ensuring an efficient flow of products from the reservoir to the end consumer.

## 1 UPSTREAM SERVICES (EXPLORATION & PRODUCTION)

These services involve finding and extracting raw materials. It also focuses on securing and developing hydrocarbon assets to grow the company's reserve base and production capacity.

## 2 MIDSTREAM SERVICES (TRANSPORTATION & STORAGE)

These services focus on moving the extracted oil and gas to processing facilities. The Midstream segment ensures the safe, reliable, and efficient movement and interim storage of crude oil, natural gas, and refined products.

## 3 DOWNSTREAM SERVICES (REFINING & MARKETING)

This sector focuses on the refining of crude oil and the distribution, trading, and retailing of petroleum products to commercial and retail customers.

# Upstream: Exploration and Production (E&P) Services

**H**i-Borde Global Oil & Gas Limited is committed to securing and developing vital hydrocarbon assets across diverse geological landscapes.

*Our Upstream segment, focusing on Exploration and Production (E&P), is the bedrock of our operations, driving the growth of our reserve base and ensuring sustainable energy supply.*



## **Geological and Geophysical (G&G) Surveys:**

Mapping the geological structures beneath the surface to identify potential reservoirs using techniques like seismic testing and data analysis.



## **Drilling Services:**

Operating land and offshore rigs, including advanced techniques like directional drilling and horizontal drilling, to create wellbores.



## **Well Completion and Workover Services:**

Installing equipment (e.g., casing and cementing steel pipes) to ensure proper well function, including wellbore cleanout, perforation, and installing artificial lift systems.



### **Production and Well Intervention:**

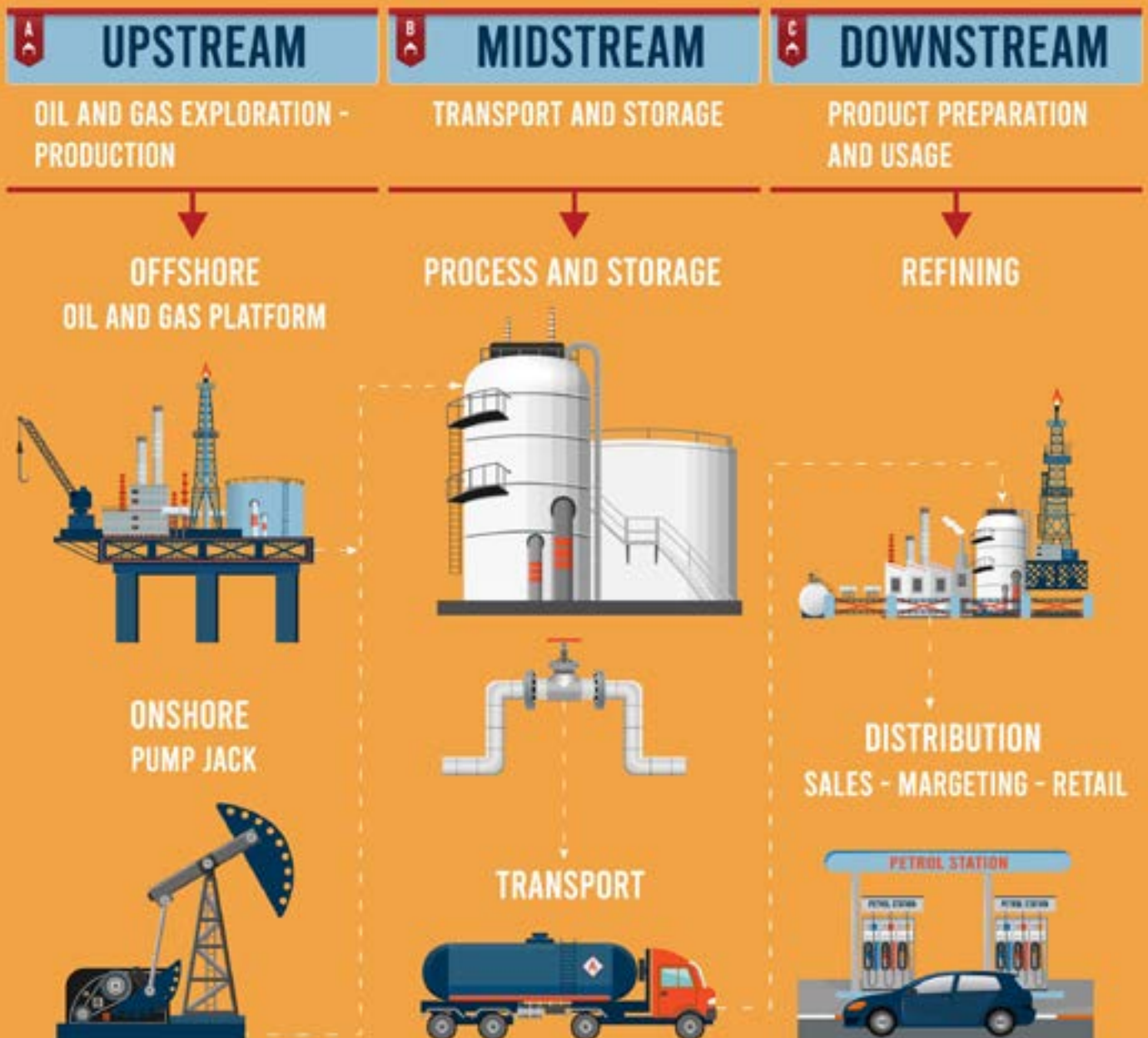

**O**ur Mid-stream services generally focuses on moving the extracted oil and gas to processing facilities. Our Midstream segment is the critical link connecting our upstream production activities to downstream refining and market distribution. These services ensure the safe, efficient, and reliable movement and temporary storage of extracted crude oil, natural gas, and natural gas liquids (NGLs) to processing and refining facilities.

Our Midstream operations manage the complex logistics required to handle large volumes of volatile hydrocarbons. We operate and maintain a robust network of infrastructure designed for high capacity, safety compliance, and operational integrity.

Operating refineries to process crude oil and natural gas into products like gasoline, jet fuel, heating oil, and asphalt.

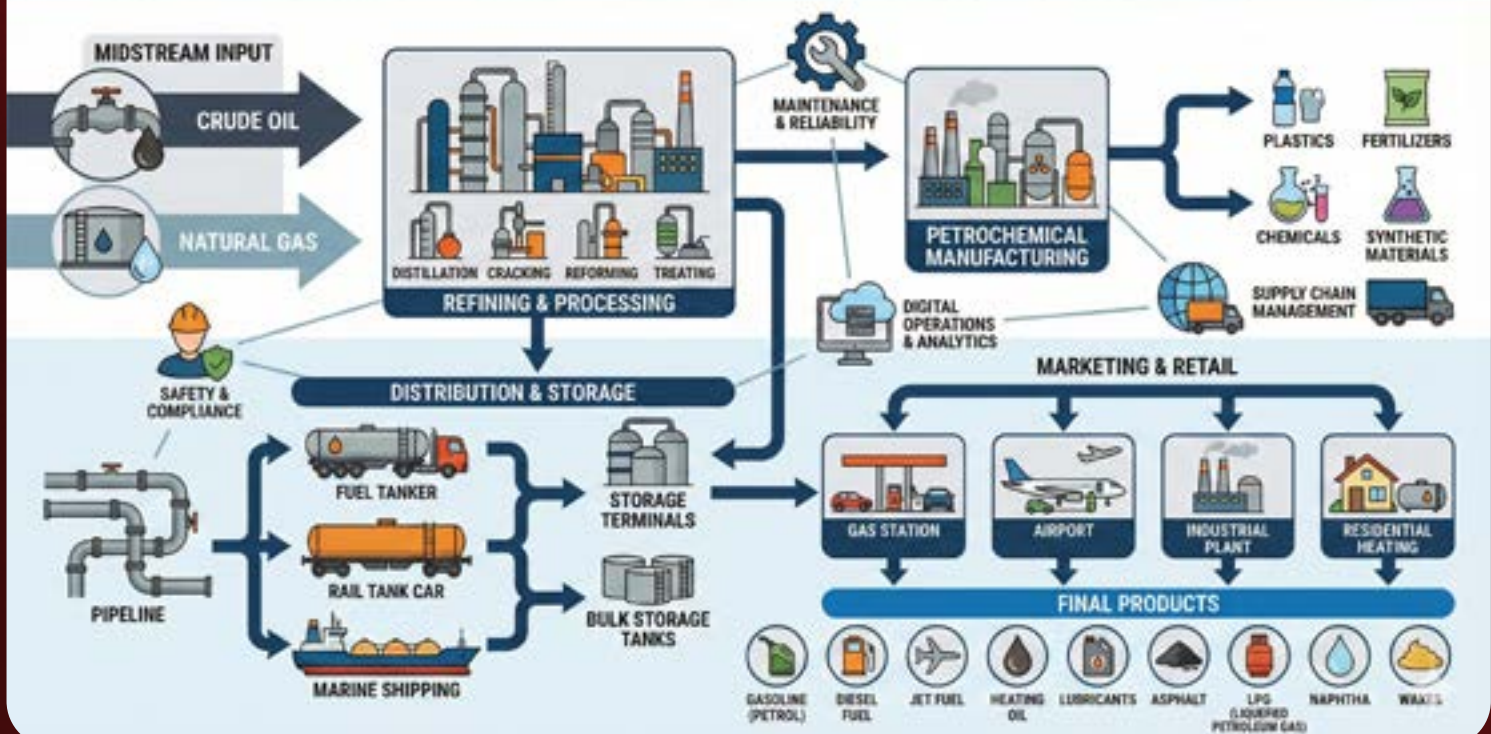
**2. Marketing & Distribution:**

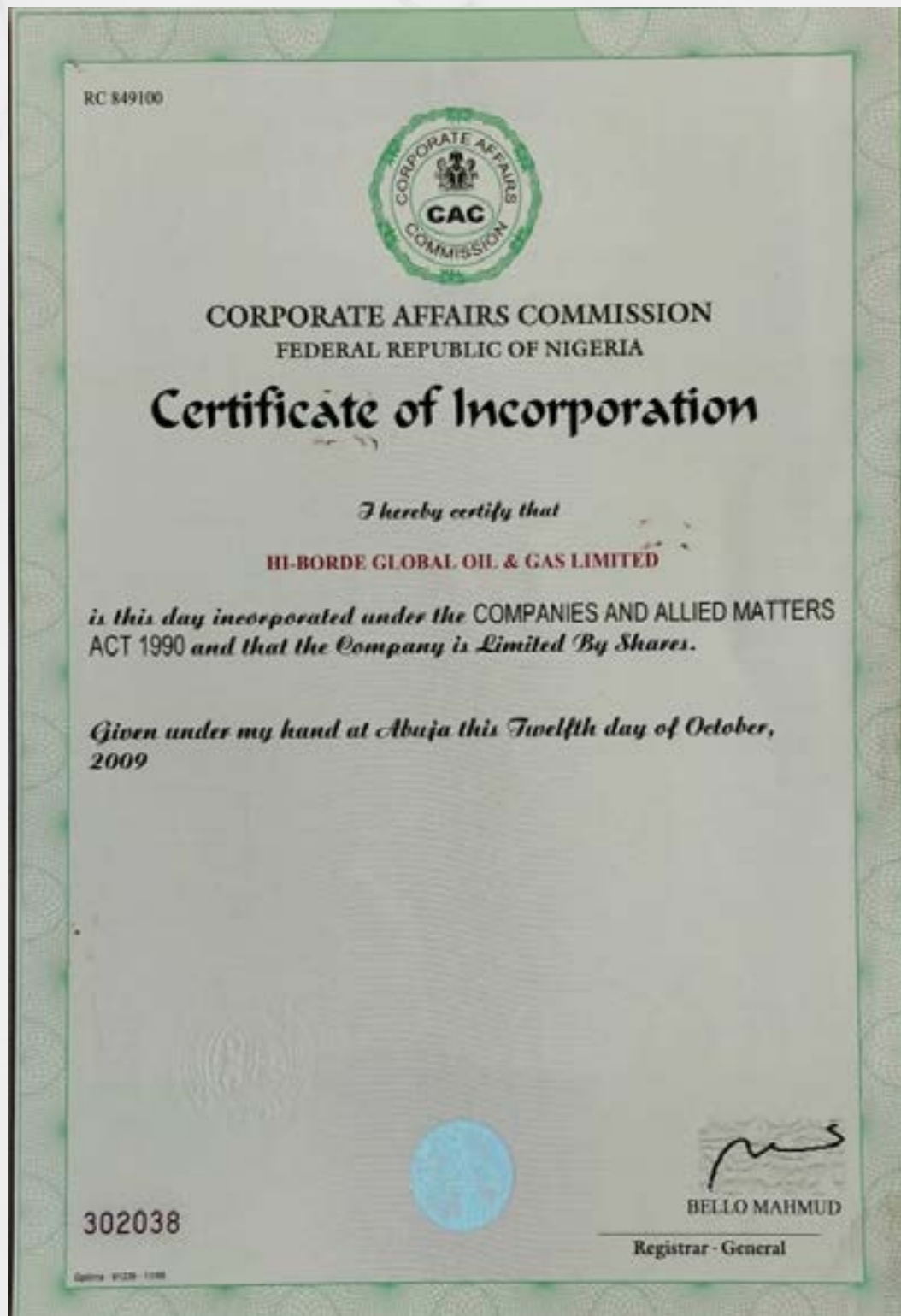
